RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO CDW GOVERNMENT, LLC UNDER COOPERATIVE CONTRACT ESCNJ/EAPA-22G FOR THE RENEWAL OF THE CISCO SMARTNET SUPPORT SERVICE PLAN FOR THE TOWNSHIP'S CISCO UNIFIED COMMUNICATIONS ("UC") VOICE-OVER IP "VoIP" TELEPHONE SYSTEM FOR A PERIOD OF ONE YEAR

WHEREAS, the renewal of the Cisco SMARTnet support service plan provides direct access 24 hours a day, 365 days a year to specialized experts in the Cisco Technical Assistance Center (TAC); extensive self-help support through Cisco's online knowledge base, communities, resources, and tools which allows for the Office of Information Technology to efficiently handle all issues with the Township's Cisco Unified Communications ("UC") Voice-over IP ("VoIP") telephone system; and

WHEREAS, the Township needs to renew the Cisco SMARTnet support service plan to continue the technical support services for the Cisco Unified Communications ("UC") VoIP telephone system such as hardware warranty replacing, software updates released by Cisco, direct anytime access to Cisco certified experts, and online self-help resources; and

WHEREAS, CDW Government LLC, 230 North Milwaukee Avenue, Vernon Hills, Illinois 60061 is an authorized dealer and reseller for Cisco Systems Inc. who has been awarded Cooperative Contract ESCNJ/EAPA-22G by the Educational Services Commission of New Jersey, and submitted to the Chief Information Officer a price quote dated October 20, 2022 (Quote# NBLX236) for the renewal of the Cisco SMARTnet support service plan for a period of one year in an amount not to exceed \$59,820.92; and

WHEREAS, funds for this purchase have been appropriated in the 2022 Information Technology operating budget, account number: 01-201-20-140-026, in an amount not to exceed \$59,820.92; and **WHEREAS**, pursuant to N.J.S.A. 40A:11-12, the Township may, by resolution and without advertising for bids, purchase goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, pursuant to N.J.A.C. 5:34-7.29(c), purchases under a State Cooperative Purchasing contract that are in excess of the contracting units bid threshold shall be made by resolution of the governing body; and

WHEREAS, the procurement of goods and services through the State of New Jersey Cooperative Purchasing Program is an open and fair process under the New Jersey Pay-To-Play Law N.J.S.A. 19:44A20.4 et seq.; now therefore
