<u>Township and Community Support Set Clary</u> <u>Anderson Arena on Path to Reopening</u>



At the July 22 Council Meeting, the Mayor and Council unanimously voted to establish a municipal utility to operate, maintain, improve, and repair the Clary Anderson Arena. In addition, they approved a new fee schedule for the facility and adopted an updated ice skating policy.

This action follows votes in June to award a management contract to a new operator, and \$1 million worth of repairs necessary to ensure the facility's reopening to the public this fall while intensive work continues on the question of its long-term future.

The Mayor and Council also expressed their gratitude for the swift and generous fundraising efforts led by the Clary Anderson Arena Association. The non-profit organization mobilized community support and raised more than \$400,000 to purchase essential equipment and fund critical repairs, an incredible fundraising achievement. The Association continues to seek community contributions to support long-term improvements and help accelerate the renovation timeline.

The Township and community came together in response to serious safety and health concerns identified earlier this year. Inspections conducted with the Building Department and Township Engineer uncovered multiple issues, including water infiltration into electrical systems, structural deficiencies, code violations, and widespread infrastructure problems.

"Thanks to dedication of our stakeholders and staff we have made huge progress towards the short-term goal of a rink that is open, safe, and not a burden to the Township's taxpayers," said **First Ward Councilor Erik D'Amato**, who chairs the Council's three-person Facilities and Infrastructure Committee. "My hope now is that donors won't let up, and continue to pitch in towards the ultimate objective of putting the facility into the hands of a self-financing and self-governing non-profit."


Moving forward, the Township, Mayor, and Council will continue to collaborate with the Clary Anderson Arena Association through the Council's project committee to develop a detailed renovation plan and prioritize the most urgent repairs.

- 2025 Budget Summary: Township Manager Stephen Marks has prepared a letter for residents and taxpayers in Montclair to provide an overview and summary of the 2025 municipal budget that was passed earlier this year. - Affordable Housing Survey Results
 - The Economic Development Committee of the Town Council in conjunction with the Planning Department, developed a survey to assess residents' points of view on affordable housing. This survey was widely distributed in April 2025 and resulted in over 1800 responses, a statistically relevant number to broadly derive respondents' positions on issues. The key takeaway was that there is a strong pro-housing cohort in town albeit with caveats.

- Township Attorney Recruitment: The Mayor & Council have continued to make progress in the
 process of recruiting a permanent Township Attorney. A Special Council Meeting was called on
 Friday August 1st, to host an executive session where interviews for the position took place. The
 next Council Meeting on August 12 will also start early at 5:00pm for the Council to conduct
 interviews during an Executive Session.

Montclair previously had 2 shuttle bus services, a jitney bus to Bay St. station, and a Senior Shuttle Bus loop. Montclair Votes to Opt-In to Garden State C-Pace Program

At the most recent Council Meeting, the Mayor and Council passed an ordinance to make Montclair a participating municipality in the Garden State Commercial Property Assessed Program, known as the "C-Pace" Program.

The C-Pace program provides eligible property owners (commercial, industrial, agricultural, and certain multi-family residences) with access to financing from the state to undertake energy-efficiency, renewable energy, water conservation, and resiliency improvements on their buildings. Owners then repay the financing through payment of an additional assessment to their municipality, similar to their real property tax.

Prohibiting synthetic pesticides on township-owned land

On July 22, the Township Council voted unanimously in favor of an ordinance, O-24-22, that:

- 1) Officially prohibits synthetic pesticides (including herbicides, insecticides, fungicides) used on township-owned properties. Note: It does not regulate pesticide use on private property.
 - 2) Formalizes the use of organic land care practices on township-owned properties.
 - 3) Ensures the town only purchases plants from nurseries that have not treated the plants with synthetic insecticides

"Montclair Township already made it a practice to refrain from the use these synthetic pesticides on townshipowned land," **explains Deputy Mayor Susan Shin Andersen**. "With advice and leadership from the Montclair Environmental Commission (MEC), the Council decided it was time to formalize that environmentally progressive practice on public property to ensure this protection for the long-haul."

Department of Community Services Director Austin Ashley adds, "The Department of Community Services (DCS) proudly supports the township's newly adopted pesticide ordinance. This new measure formalizes practices that DCS has long implemented across Montclair's public spaces. You can count on our parks and public areas being clean and maintained free of toxic chemicals, so when families and pets are out enjoying themselves, they don't have to worry."

"Montclair is one of the first NJ towns to pass such a strong ordinance! We are hopeful that other towns will follow suit and this new regulation will inspire more Montclair residents to adopt similar environmentally responsible, chemical-free practices on their yards, fostering a healthier Montclair for residents, pets, birds, pollinators and beneficial insects, waterways, and wildlife," **shares Suzanne Aptman, Montclair Environmental Commission Chair.** "The use of synthetic pesticides is not necessary to create a thriving, eco-beneficial, mosquito-free yard. In fact, using these chemicals can do just the opposite. Our eco-systems need support from all of us more than ever!"

Important highlights from the Ordinance's introductory statements:

- scientific studies associate exposure to pesticides, including herbicides, insecticides, and fungicides, with asthma, cancer, developmental and learning disabilities, nerve and immune system damage, liver or kidney damage, reproductive impairment, birth defects, and disruption of the endocrine system; and
- infants, children, pregnant women, the elderly, people with compromised immune systems and chemical sensitivities are especially vulnerable to pesticide effects and exposure; and
- pesticides can be harmful to pets, beneficial insects and pollinators, birds and other wildlife including threatened and endangered species, soil microbiology, plants, and natural ecosystems; and
- the use of hazardous pesticides is not necessary to create and maintain green lawns, recreational areas, and landscapes, nor reduce mosquito populations, given the availability of viable alternative organic land care practices and products.




Vision Zero Pledge

Traffic & Street Safety



Traffic Improvements: From 2024-2025, the township installed a number of traffic safety improvements. A map of the improvements is available at the link below. The improvements include:

- 6 new push-button flashing pedestrian lights
- 14 new multi-way stop intersections
- reflective traffic posts in 38 locations
- 2 intersections with painted curb extensions
- 1 new traffic signal with enhanced pedestrian safety features
- 6.7 miles of Township roadways resurfaced and repainted

Ongoing Speed-Reducing Studies: The Township is actively conducting several speed-reducing studies at priority locations throughout the township in 2025. In addition, Essex County is is the process of upgrading county road intersections. A map of these studies is also available at the link below.

Interactive Traffic Safety Map: The Township has also created an interactive map for traffic safety in Montclair, where you can filter out several "layers" to see the data relevant to you. You can see specific layers such as multi-way stop intersections, crossing guard locations, crash data from recent years, and more.

E-Bike & E-Scooter Safety Information

Many residents have recently been reaching out concerns over the use of e-bikes and e-scooter in our community. The Township has gathered some helpful information and resources below:

* Restrictions may vary by agency. PATH and NJT restrict non-collapsible vehicles during peak travel times. Bus racks have limited availability and may not fit all bikes.

E-mobility devices make it easier to:

- · Save on gas, parking, and rideshare costs.
- Access destinations without needing to walk or drive.
- Reduce carbon emissions.
- Make "first-mile" and "last-mile" connections for bus and train trips.
- Climb hills and keep up with traffic without getting sweaty.
- Help people with limitations due to age, physical fitness levels, or disabilities.

Low-speed e-bikes and e-scooters are regulated like bicycles. Drivers of low-speed e-bikes and e-scooters:

- Must ride in the same direction as traffic and obey all traffic lights, signs, and signals.
- Are advised to wear helmets to minimize potential head injury.
 Helmets are required in NJ for youth under age 17.
- Must park devices without blocking pedestrian and/or wheelchair access
- Should not ride on sidewalks. Off-road trails generally do not allow motorized bicycles, but may allow e-bikes and e-scooters.
 Regulations vary by municipality and county. Check all local ordinances and policies. Ride slowly in areas with pedestrians.

The Water Bureau is finalizing service line inventory on the customers side to develop a program to replace lead lines as per the NJDEP requirements. The Water Bureau will begin replacing Lead Lines in 2026, if addresses do not have inventory updated, they may be left off the project and must replace service line at their cost.
